Challenge

Banking and financial services industry has been one of the early adopters of data analytics and digital technologies. 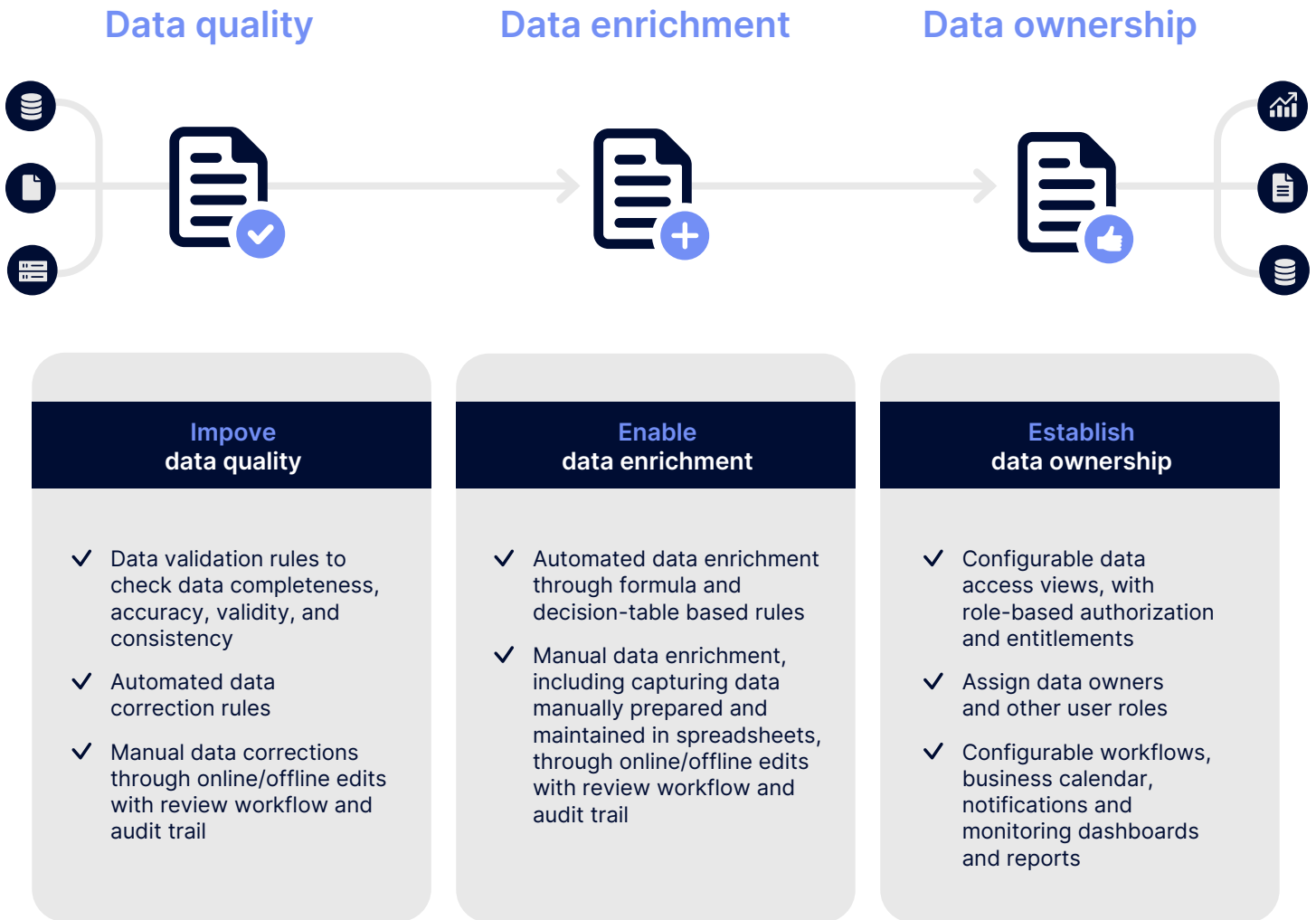
Solution

Highlights

- **Data quality**
Gain full visibility and control over the quality of data and ensure data completeness, accuracy, validity, and consistency through data validation rules and automated and manual audited data correction processes.
- **Data ownership**
Establish well defined ownership and governance with clear roles and responsibilities to own their datasets and ensure completeness, accuracy, and timely delivery of attested data.
- **Data standardization**
Derive attributes at the lowest granularity, as required for downstream data analysis and consumption but not available from source. Derive standard internal or regulatory codes.
- **Manage manual data**
Manage and integrate data manually maintained in spreadsheets into the data ecosystem through file uploads or online data edits.
- **Data centralization**
Centralized data curation flow and curated data repository enables data comprehensiveness, uniformity, and consistency to meet the data needs of all the downstream solutions and use cases.
- **Regulatory compliance**
Unified data flow architecture powered by the Data Curation Platform is a stepping stone and pivotal towards compliance with standard guidelines and principles laid out for data management and reporting processes, such as BCBS 239.
- **Flexible deployment**
Deployable on premise or on the cloud and can seamlessly integrate into the existing data ecosystem by operating on an existing or a new data warehouse/repository.

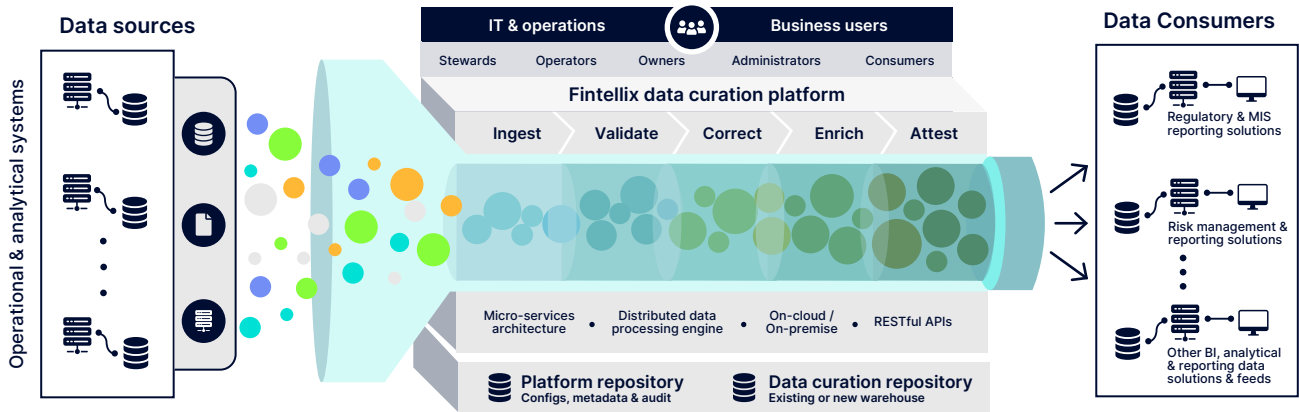

Controlled data flows

Centralized data enrichment
